Teacher candidates spend a full semester in their student teaching experience. Whenever possible, the semester prior to student teaching, students are placed for pre-internship field experiences with the clinical teacher who will supervise their internship during the professional semester. Art Education students complete two placements at two different school levels (elementary, middle, and/or high).

Prospective teachers are required to take introductory level courses that 1) address the unique learning needs of students with disabilities, students with limited English proficiency, and learners at risk of academic difficulties, and 2) provide instructional strategies to address these needs. Field experience opportunities and student teaching assignments provide prospective students with experience in various areas (urban, suburban, and rural, including low-income). Memorandums of Understanding (MOUs) are reviewed annually and establish collaboration between the UNCP Educator Preparation Program and public school units (PSUs) to ensure access to field instruction. Prospective teachers engage with diverse students, including children with disabilities, limited English proficient students, and low-income families. In addition, we offer a seminar every semester for our interns that focuses on the needs of limited English proficient students. More information about limited English proficient students is included in the SED 3310 core course

(Introduction to Exceptional Children), which is taken by all education majors, The needs of students from low-income families are addressed in a similarly required methods class in each preparation program.

4. Description of strategies used to achieve goal, if applicable:

Faculty continue to be energetic and intentional in sharing their passion for the teaching profession, particularly in mathematics. This enthusiasm is often contagious; even students outside of education courses are encouraged to consider teaching as a future career, with some ultimately choosing to change their major to math education. In 2025, we hosted a Pi Day event that celebrated the joy and beauty of mathematics with local middle school students. The event also actively engaged our college students—especially math and math education majors—as facilitators. This dual exposure not only encourages our college students to explore teaching as a profession but also inspires younger students to appreciate mathematics more deeply. Additionally, we consistently monitor and advise our math education majors through regular meetings each semester, ensuring they stay on track with their plan of study and are supported in their academic success.

5. Description of steps to improve performance in meeting goal or lessons learned in meeting goal, if applicable:

Moving forward, we have streamlined the curriculum for math education majors by reducing the number of required method courses from five to two. We believe this change will make the program more accessible and less intimidating for prospective students, ultimately improving both enrollment and overall program success. We also plan to build on successful initiatives. Another Pi Day event is scheduled for March 2027, as we have seen the value it brings to both outreach and student engagement. Additionally, we will reinstate “Why Teach Week” in Fall 2026. Previously held virtually in 2024, this event allowed UNCP alumni to share their classroom experiences with current students, benefiting both groups. After recognizing its absence in Fall 2025, we are committed to making it an annual offering. Finally, we will continue to foster a culture that highlights the value and joy of teaching mathematics for all students, regardless of their major. We have learned that personal accompaniment, authentic witness, and consistent faculty support play a critical role in encouraging perseverance among math education majors.

Within the 2024-2025 year, the coordinator of the Undergraduate Science Education (SCE) program worked on identifying students enrolled in the UG SCE program, gaining advisor status of those students, establishing relationships with those students, and becoming familiar with their course audits and individual needs. Although the Science Program set a goal of preparing at least one teacher, after gaining access to their degree audits it was determined that none of the students within the program were eligible for graduation until the 2025-2026 year.

The Undergraduate Special Education Program implements a systematic continuous improvement process grounded in multiple measures of candidate performance and program effectiveness. Key data sources include edTPA performance (rubric-level analysis), course-embedded assessments, candidate GPA, disposition evaluations, and faculty-developed key assessments aligned to professional standards. Faculty are actively engaged in the Gateway Course Project, a faculty-driven initiative designed to improve candidate performance and progression. Disaggregated data from SED 3310 (e.g., assignment performance, course pass rates, and candidate feedback) are analyzed each term to identify areas for instructional improvement. Resulting actions include targeted scaffolding, revised assessment criteria, and enhanced feedback mechanisms to support candidate success.

Emphasis on the use of technology to enhance teaching and learning remains a focus of the Educator Preparation Program at UNCP. Teacher candidates incorporated word processing, spreadsheets, interactive Internet tools, web 2.0 tools, cloud-based applications, Microsoft Office, Google Suite, Canvas, Smartboards and Smart Notebook applications as well as instructional apps for classroom use within assignments in method courses. Special Education candidates used the above mentioned instructional technologies as well as evidence-based strategies and assistive technology devices to enhance students with disabilities educational experiences in K-12 settings. All candidates were prepared to engage in positive digital citizenship activities, lead all students to become active participants in setting educational goals, monitor learning and assess student progress through digital tools, and design technology-enriched learning experiences. Culminating experiences in method courses and student teaching encompassed the use of technology demonstrated in effective lesson plans. The edTPA assessment was used to measure and support subject-specific and content knowledge in program completers, including the integration of technology to collect, manage and analyze data as well as the application of the principles of universal design for learning. For the purpose of enhancing online course delivery and student interaction, faculty have incorporated WebEx and Zoom web conferencing systems to transform impersonal communication and reflect upon critical assignments in each program area. Candidates also used Canvas as a learning management system. Specific program areas use more specialized software, such as Geometer's Sketchpad in secondary math and Finale in K-12 music. Some programs incorporated the use of GoReact, an interactive cloud-based platform for feedback, grading, and critiquing of candidate video assignments.

All prospective teacher candidates are required to take an introductory level course, SED 3310-Introduction to the Exceptional Child, designed to introduce the foundations of special education: the concept, purposes and responsibilities, laws and policies, principles and practices for meeting the educational needs of children considered at-risk or identified with disabilities. The course provides a study of the needs, characteristics, and categories of exceptional children, as well as the important role parents and families play in the educational planning and decision-making process. Policies, laws, and procedures are also discussed to ensure students understand how to effectively and legally educate students within these identified groups. Close programmatic attention is given to providing candidates with opportunities to examine and participate in the various stages of development of the Individualized Education Plan (IEP), from pre-referral to receipt of specialized services. Moreover, each course provides students with a field experience/service learning component in which course material can be applied through personal reflections and group discussions. Furthermore, the edTPA assessment was used to measure and support subject-specific and content knowledge in program completers, including the application of the principles of universal design for learning and possible instructional accommodations for students with disabilities in the general classroom.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

SED 3310, Introduction to the Exceptional Child, serves as an initial experience to all prospective teacher candidates as members of IEP teams. Within the course, candidates engage in active discussion of the roles of general and special educators in providing exceptional learners an individualized education program as defined by IDEA of 2004. One main assignment required within the course is the completion of an IEP based on a case study using the forms adopted by the NC Department of Public Instruction. Other courses, such as SED-3340-Strategies for Instruction of Students with Mild to Moderate Disabilities, provide teacher candidates who select Special Education as a professional concentration area the opportunity to design instructional lessons including accommodations and modifications for students with special needs as indicated in the IEP. Furthermore, candidates are encouraged to participate in IEP meetings with supervising clinical teachers during field experience and the internship semesters. Elementary Education and Special Education candidates matriculate through SED-4330: Diagnosing and Remediating Mathematics Problems. This course of study is designed for teacher candidates to have the knowledge and skills to use systematic, explicit, multi-sensory methods to diagnose and remediate mathematics skills. Candidates will also learn how to understand and provide the essential components of math instruction.

c. Effectively teach students who are limited English proficient.

All prospective teacher candidates are required to take SED 3310, Introduction to the Exceptional Child, which provides an active discussion of the characteristics and educational needs of students identified as limited English proficient (LEP) and culturally diverse populations. Furthermore, method courses across the program incorporate specific instructional strategies focused on advancing the academic and language achievement of limited English proficient students across grade levels and content areas. The edTPA assessment was used to measure and support subject-specific and content knowledge in program completers, including the application of the principles of universal design for learning and possible instructional accommodations for students who are Limited English Proficient.

a. Teach students with disabilities effectively

Prospective special educators are provided with a rigorous program focused on current and relevant evidence-based practices and strategies needed in order to promote student success for all students with mild to moderate disabilities. A strong emphasis is placed on the prospective special education teacher learning skills to effectively collaborate with parents and other professionals as well as to identify and locate local and community resources. Through the various course material and assignments, prospective special educators are provided with the following educational opportunities: 1) an in-depth examination and application of the characteristics of and programming needs for students with disabilities and limited English proficiency; 2) the review and application of the NC Essential Standards objectives in the areas of mathematics, reading, and writing; 3) the incorporation of the North Carolina School Improvement Project- Foundations of Reading and Math Foundation into required methods courses and 4) the creation of lesson plans that incorporate various assistive technology devices, assessment tools and their results, and adaptive instructional strategies. Hands on experience in developing Individualized Education Plans (IEP), Functional Behavioral Assessment (FBA) as well as a Behavioral Intervention Plan (BIP) are provided with direct guidance from Special Education faculty. Moreover, candidates are provided with classroom-based opportunities (field experiences) in which course material can be applied in a meaningful and practical manner. Such classroom-based opportunities are closely monitored and reviewed by the Special Education faculty to ensure that the prospective educator is gaining appropriate and accurate information regarding how to effectively teach students with disabilities and those with limited English proficiency. Furthermore, the edTPA assessment was used to measure and support subject-specific and content knowledge in program completers, including the application of the principles of universal design for learning and instructional accommodations for students with disabilities.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

SED 3310, Introduction to the Exceptional Child, serves as an initial experience to prospective special educators as members of IEP teams. Within the course, candidates engage in active discussion of the roles of general and special educators in providing exceptional learners an individualized education program as defined by IDEA of 2004. One main assignment required within the course is the completion of an IEP based on a case study using the forms adopted by the NC Department of Public Instruction. Well designed IEPs are discussed across method courses with specific emphasis in the appropriate use of accommodations and modifications. For example, SED-3340-Strategies for Instruction of Students with Mild to Moderate Disabilities, provides teacher candidates the opportunity to design instructional lessons including accommodations and modifications for students with special needs as indicated in the IEP. Furthermore, candidates are encouraged to participate in IEP meetings with supervising clinical teachers during field experience and the internship semesters. Elementary Education and Special Education candidates matriculate through SED-4330: Diagnosing and Remediating Mathematics Problems. This course of study is designed for teacher candidates to have the knowledge and skills to use systematic, explicit, multi-sensory methods to diagnose and remediate mathematics skills. Candidates will also learn how to understand and provide the essential components of math instruction.

Candidates are required to take SED 3310, Introduction to the Exceptional Child, which requires active discussion of the characteristics and educational needs of students identified as limited English proficient and culturally diverse populations. Furthermore, method courses across the program incorporate specific instructional strategies focused on advancing the academic and language achievement of limited English proficient (LEP) students across K-12 grade levels and content areas. The edTPA assessment was used to measure and support subject-specific and content knowledge in program completers, including the application of the principles of universal design for learning and possible instructional accommodations for Limited English Proficient students.
