# ARTICULATION AGREEMENT

Between

The University of North Carolina at Pembroke

and

**Fayetteville Technical Community College** 

### I. PURPOSE

The purpose of this Articulation Agreement is to acknowledge that students of Fayetteville Technical Community College (FTCC) may transfer to The University of North Carolina at Pembroke (UNCP) Bachelor of Arts in Criminal Justice (BA-CRJ); Bachelor of Science in Exercise and Sport Science, Exercise Physiology Track (BS-E&SS); and the Bachelor of Interdisciplinary Studies (BIS) degree programs following completion of the Associate's degree in General Education (AGE) program for Army Special Operations Forces (ARSOF) Soldiers at FTCC.

### II. ELEMENTS

- To be eligible for application to enroll the student must submit proof of having been awarded an AGE through the program for ARSOF from FTCC in the form of an official transcript from FTCC.
- 2. Students who complete the AGE through the program for ARSOF from FTCC will be eligible for a block transfer of 60 semester credits earned as degree credits and acceptance into the BACRJ, BS-E&SS, or BIS degree program at UNCP. Acceptance into the BIS degree program is contingent on the condition stipulated in Section II, Paragraph 3, of this Articulation Agreement (below).
- 3. For the purposes of this Articulation Agreement, the AGE through the program for ARSOF from FTCC will be considered the equivalent of an Applied Associate in Science degree for entry into the BIS program at UNCP. This equivalency will remain in force for all students who complete the AGE and enroll at UNCP by January 2014. This equivalency may be renewed by UNCP. UNCP will notify FTCC of their intention to renew this equivalency in writing no later than ninety days prior to the expiration of the equivalency period.
- 4. The 60 hour block transfer will be considered to satisfy the following requirements:
  - 24 HOURS OF GENERAL EDUCATION, including: FRS 1000, PED 1770, PED 1460, SPE 2010, ENG 1050, ENG 1060, MAT 1050, LANGUAGE (6 hrs only), and GGY 1010:
  - 6 HOURS OF SPECIFICALLY ARTICULATED COURSES, including: CSC 1000 (3 hrs) and CRJ 2010 (3 hrs)
  - 30 HOURS UNIVERSITY WIDE ELECTIVES for the BA-CRJ and BS-E&SS Majors or
  - 30 HOURS FOR VALIDATION OF AAS DEGREE for BIS Majors.
- 5. Students accepted into the BA-CRJ, BS-E&SS, or BIS degree programs at UNCP through the program for ARSOF from FTCC will be required to satisfy the remaining General Education Requirements of UNCP:
  - a. Nine hours of Arts and Humanities, choosing 3 of the following: 3 hours of Fine Arts, 3 hours of Literature, 3 hours of History, 3 hours of Philosophy or Religion.
  - b. Six hours of Social Sciences from choosing 2 of the following: 3 hours of Economics, 3 hours of Political Science, 3 hours of Sociology.

- c. Six hours of Natural Science, choosing 2 of the following: 3 hours of Biology, 3 hours of Chemistry, 3 hours of Earth Science, 3hours of Physical Science.
- 6. Credit earned through any combination of Transfer Credit, Challenge Credit or Experiential Credit will not exceed 75 percent of total credits required for the FTCC AGE. Credits from military training used to complete requirements for a FTCC AGE may not be applied toward courses in the UNCP degree programs if they are included in the block transfer of credit as part of this agreement, except for up to six (6) credit hours for individual courses within each BACRJ and BS-E&SS Major as may be approved by the Chairs of the Departments in which these majors reside within UNCP after review of individual transcripts.

## III. TERMS

- This Articulation Agreement is effective as of the date of the fully executed document, and shall continue until terminated. Both parties must approve amendments to this Articulation Agreement in writing.
- 2. Once each year, and only to the extent permitted by Federal law, FTCC will provide UNCP with the names and contact information (including physical mailing address, email address, and phone number) of all alumni of the FTCC AGE program. This report on FTCC letterhead will state "The below students from Fayetteville Technical Community College have received Associate of General Education degrees under FTCC's AGE Program."
- 3. Once each year, UNCP will provide FTCC a report on students of FTCC's AGE program. The report on UNCP letterhead will state "The below students from Fayetteville Technical Community College have transferred to The University of North Carolina at Pembroke, have completed at least three terms and are making satisfactory academic progress through their program (as defined in the UNCP catalog)."
- 4. Either party may terminate this Articulation Agreement without cause upon 90 days written notice to the other party. Notwithstanding the foregoing, either party may terminate this Articulation Agreement immediately in the event that participation under this Articulation Agreement may give rise to a violation of any requirement of federal or state law or regulation or the requirements of any accrediting agency having jurisdiction.
- 5. Admission criteria, academic requirements, and other admission requirements will be subject to the applicable Catalog at the time of the students' admission to the UNCP degree programs stipulated herein.
- 6. Qualified faculty members must teach all courses accepted for transfer to The University of North Carolina at Pembroke. Faculty teaching courses for transfer must meet the standards set forth in Principles of Accreditation Comprehensive Standard 3.7.1 by the Southern Association of Colleges and Schools.
- 7. The parties grant to each other a non-exclusive, non-transferable license to use each other's trademarks and servicemarks in furtherance of the articulation coordination detailed herein or in a manner solely for the purpose of identifying and communicating the existence of the relationship to FTCC students and alumni. Use of trademarks, servicemarks and logos will comply with use policies of the originating institution. The parties shall discontinue the use of the licensed marks and return any and all files and materials containing the licensed marks supplied by the owner at termination or expiration of this Articulation Agreement. Neither party

grants to the other any interest in the other party's trademarks. Should either originating institution request, in writing, that a particular use of the originating institution's trademarks and/or servicemarks be discontinued, the non-originating institution shall cease and desist such use of the trademarks and/or servicemarks.

- 8. The parties hereto will have the relationship of independent contractors for all purposes. Each will have complete control over its own performance and the details of accomplishing its own obligations under this Articulation Agreement. In no event will the agents, representatives or employees of one party be deemed to be agents, representatives or employees of the other.
- 9. A duly authorized representative of each party may execute this Articulation Agreement, either by electronic or facsimile transmission, each of which will be considered an original.
